Each module has online test. The passing criterion of each module is 50%. The test will comprise of 20 objective questions and the time limit is 20 minutes. Participant will be given 3 attempts to pass the module. Unless the participant clears the module, he/she cannot proceed further to the next module. If the participant is unable to pass any module in 3 attempts, the course will get terminated automatically.</li><li>• <b>Certificate</b>: Certificates can be downloaded after the successful completion certificate from the e-learning site.</li></ul>
