BOARD OF GOVERNORS

The existing 14 Board members (8 representing the Central Organizations of Employers and 6 representing the Central Organizations of Workers) were nominated by the Ministry of Labour & Employment, Govt. of India vide Ministry's letter No. V-18011/03/2021-ISH-I dated 14th July 2021 and dated 17th August, 2021 for a term of three years which was ended on 13th July 2024.

In view of the delay in getting new nominations from the Ministry and to keep the continuity of the Board, the Board at its 190th meeting held on 17th January, 2025 passed the resolution that, out of 14

previously nominated members, the 13 members (who have attended the meetings in the past) shall continue on the Board till the receipt of new nominations from the Ministry or till the next 1 year i.e. up to 31st Dec., 2025, whichever is earlier.

Also, the 21st Election to the Board of Governors was conducted during the year.

ACTIVITIES/COLLABORATION

SIGNING OF MoUs/AGREEMENTS

National Safety Council (NSC) has consistently pursued long-term collaborations with its leading corporate members and other organisations, working to meet their Occupational Safety and Health (OSH) needs through strategic partnerships. As part of these efforts, NSC has entered into several Memorandum of Understanding (MoUs) / agreements to strengthen these alliances.

- 1. On 8th May 2024, NSC and the Quality Council of India (QCI) entered into a one-year MoU signed in New Delhi by Dr. Lalit R. Gabhane, Director General of NSC, and Dr. A. Raj, Chief Executive Officer of QCI. QCI, an autonomous organization registered under the Societies Registration Act of 1860, plays a pivotal role in establishing and managing India's national accreditation system while promoting quality across various dimensions of public life. It operates through multiple specialized boards, including NABCB, NABL, NABH, NABET, and NBQP. DG NSC is a member on the Board of NBQP (National Board for Quality Promotion). The scope of the MoU is specifically aligned with activities under the Quality Bharat Mission (QBM), which is actively driven by NBQP.
- 2. In a significant move, NSC India entered into its first formal partnership with The Life and Building Safety Initiative (LABS), through a one-year MoU signed on 17th October 2024. The signing ceremony took place during the Sustainable Trade Summit (SUTRA) 2024

hosted by LABS in Gurugram, Haryana. Dr. Lalit R. Gabhane, Director General, signed on behalf of NSC India, while Mr. D.A. Wensing, Executive Board Member, represented LABS.

LABS, headquartered in the Netherlands, is an industry-led programme committed to reducing preventable fire, electrical, and structural safety risks in manufacturing sectors across apparel, footwear, accessories, and home textiles.

This MoU marks the beginning of a joint effort to foster knowledge exchange and harness the complementary strengths of both organizations. The collaboration will focus on enhancing safety culture within the apparel and textile manufacturing industries through focused interventions.

3. To further strengthen its long-standing relationship, a one-year MoU had been signed between NSC and Steel Authority of India (SAIL) for the 14th consecutive year on 5th Nov., 2024 by Dr. Lalit Gabhane, DG on behalf of NSC and Shri Shashi Vashishta, CGM (Safety), SAIL Safety Organizations on behalf of SAIL. The MoU can be extended by mutual consent, aims to uphold the highest standards in Occupational Safety, Health and Environment through technical co-operation and knowledge exchanges between the two organizations. Several initiatives, including safety audits, training programmes, OSH Consultancy Services, etc. are planned across various locations of the SAIL.

- 4. To promote co-operation, a 1-year MoU was signed on 25th November, 2024 between NSC and The Indian Institute of Management Mumbai (IIMM) for the first time. The MoU was signed by Dr. Lalit R. Gabhane, DG on behalf of NSC and Prof. Manoj K. Tiwari, Director on behalf of IIMM at Mumbai, IIMM is an educational Institution conducting programmes such as Management Development Programmes (MDP), Unit-based Programmes (UBP) and Postgraduate courses. This MoU aims to make co-operation and collaboration in the areas of management education, training, research and allied knowledge areas by conducting training, online programmes on safety, organising joint events like symposia, workshops, etc.
- 5. To establish a collaboration with the Petroleum and Natural Gas Regulatory Board (PNGRB), a 5-year MoU was signed between NSC and PNGRB for the first time on 27th February, 2025 by Dr. Lalit R. Gabhane, DG on behalf of NSC and Shri Anjan Kumar Mishra, Secretary on behalf of PNGRB at New Delhi. The agreement can be extended by mutual consent. PNGRB is a statutory regulatory body constituted under Petroleum and Natural Gas Regulatory Board Act, 2006. MoU aims to achieve mutual collaboration between the parties to the objectives of promoting knowledge sharing, providing support for safety training, collaborating to design and conduct webinars on safety to raise awareness and knowledge

across the industry, and to leverage NSC's expertise to develop a dedicated centre of excellence focused on advancing safety standards in the sector, etc.

ASIA PACIFIC OCCUPATIONAL SAFETY AND HEALTH ORGANISATION (APOSHO)

NSC'S PARTICIPATION IN APOSHO-38 COMMITTEE MEETINGS, CONFERENCE AND AGM

On the approval of the Board of Governors of NSC, a two-member NSC delegation comprising Shri G.K. Srivastav, Vice Chairman (W), and Dr. Lalit R. Gabhane, Director General participated in the APOSHO-38 Committee Meetings, Conference, and Annual General Meeting (AGM) held from 14th to 17th November 2024 in Bangkok, Thailand. The event was co-organized by the Safety and Health at Work Promotion Association (Thailand) (SHAWPAT) under the patronage of Her Royal Highness Princess Maha Chakri Sirindhorn, in collaboration with the Occupational Health and Safety at Work Association (OHSWA) and other key stakeholders from government, industry, and academia. The theme of the APOSHO-38 Conference was "Towards the Sustainability on Safety, Health and Wellbeing".

TAKING OVER THE CHAIRMANSHIP OF APOSHO-39

As per the APOSHO tradition, the APOSHO flag was formally handed over to NSC India at the conclusion of the AGM of APOSHO-38, signifying its role as the incoming host of APOSHO-39. Shri G.K. Srivastav and Dr. Gabhane, while accepting the flag, extended a warm welcome to all member organizations to participate in the APOSHO-39 Annual Conference and AGM, scheduled to be held from 26th to 29th November, 2025 in Dwarka, New Delhi, India, Further, copies of the leaflet printed by NSC giving preliminary information regarding theme, programme of the Conference, fee structure, etc. was distributed among the participants at the APOSHO-38. Accordingly, APOSHO-39 International Conference and AGM will be hosted by NSC India from 26th to 29th November 2025 at India International Convention and Expo Center, YASHOBHOOMI, Dwarka, New Delhi.

INDO-GERMAN COOPERATION

In pursuit of advancing Occupational Safety and Health (OSH) in India, NSC signed a three-year Memorandum of Understanding (MoU) with the German Social Accident Insurance (DGUV) in April 2022. This strategic partnership has fostered several joint activities with NSC, actively engaging in programmes organized by DGUV and the Indo-German Focal Point.

To explore opportunities for expanding this collaboration, the German Embassy convened a Round Table Discussion on OSH on 18th June 2024 at New Delhi. The forum brought together key stakeholders from both India and Germany to exchange insights and propose new avenues for enhancing workplace safety. Invited as a key contributor, the Director General, NSC, emphasized the critical need to address safety in the agriculture sector, an unorganized domain that employs a substantial share of India's workforce.

This engagement reflects the growing momentum in Indo-German cooperation and NSC's ongoing commitment to elevating safety standards across diverse sectors.

DG-NSC CHAIRED CHD:07 AND CHD:08 COMMITTEE MEETINGS OF BIS

As the National Standards Body of India, the Bureau of Indian Standards (BIS) plays a pivotal role in developing Indian Standards across various industrial sectors, covering products, testing methods and services. The two key BIS committees, CHD:07 and CHD:08 are chaired by DG, NSC.

CHD: 07 - Chemical Hazards Sectional Committee: The Committee is responsible for drafting and formulating standards and codes of practice related to chemical hazards.

- 1. 13th meeting of the Committee was held on 16th April 2024 in New Delhi, with 30 members in attendance.
- 2. 14th meeting of the Committee was held on 27th Sept., 2024 on virtual mode. The meeting was attended by 26 members.
- **3.** The 15th meeting of the Committee was held on 21st March, 2025 on hybrid mode and was attended by 23 members.

In the above meetings, the Committee undertook a comprehensive review of various Indian Standards and assessed the feedback received from its members and decisions were made to revise, amend, or reprint several standards based on the comments.

CHD: 08–Occupational Safety and Health Sectional Committee: The Committee is tasked with drafting and formulating standards and codes of practice in the field of occupational safety and health.

- 26th meeting of the Committee was held on 10th Sept., 2024 on a virtual mode and attended by 24 members.
- **2.** 27th meeting of the Committee was held on 10th March, 2025 at Mumbai and attended by 24 members.

At these meetings, the Committee reviewed various Indian Standards and comments received from its members and decided to revise them based on the comments. Shri A.Y. Sundkar, Director also attended the meetings.

VISIT OF CIVIL DEFENCE VOLUNTEERS TO NSC OFFICE

Western Coal Fields, Nagpur designated as a 'Vital Installation of Civil Defence (VICDU)' in Maharashtra, actively participated in a comprehensive Disaster Management training programme organized by Civil Defence, Maharashtra.

The delegation comprising 21 Civil Defence Volunteers and security personnel visited NSC office on 24th July, 2024 for an interactive session focused on mines safety. The short programme included a welcome and introductory segment, a keynote address by the Director General, NSC, and a focused technical session on "Safety in Mining" conducted by Shri R. R. Deoghare, Director, NSC. The session addressed critical safety challenges in the mining sector and highlighted industry best practices.

NSC OFFICIAL NOMINATED ON TECHNICAL COMMITTEE OF PNGRB

Under the provisions of the PNGRB Act, 2006, the Petroleum and Natural Gas Regulatory Board (PNGRB) is entrusted with setting technical and safety standards governing petroleum,

petroleum products, and natural gas activities. These regulations encompass the construction and operation of pipelines and other downstream infrastructure.

PNGRB regularly develops and updates these standards through its Technical Committees, which include key stakeholders and subject-matter experts. This process leverages industry insights and technological advancements to ensure robust regulatory frameworks. NSC nominated Shri A.Y. Sundkar, Director to serve on the Technical Committee for the PNGRB (ERDMP) Regulations, 2010. The meetings attended by Shri Sundkar. This nomination underscores NSC's active participation in regulatory development and its continued commitment to strengthening safety protocols across the petroleum and natural gas sector.



EFFORTS TAKEN TO STRENGTHEN THE ACTIVITIES OF THE COUNCIL

- 1. To advance the quality and visibility of NSC's training programmes, the Trainers Meet was organized on 29th April, 2024. The event brought together around 40 distinguished faculty members from across India. It served as a strategic platform to emphasize the importance of unified efforts among faculty towards elevating safety standards through high-quality training. The session was led by Shri R. R. Deoghare, Director, and Shri V. V. More, Assistant Director, NSC, who guided discussions on aligning training methodologies with NSC's broader mission of promoting excellence in safety practices.
- 2. With an objective to advance the knowledge and skills of auditors in various safety domains and to provide a platform for networking among experts, Safety Audit Summit was organised by NSC on 2nd July, 2024 at Navi Mumbai. DG, NSC inaugurated the summit. It emphasized the critical role of safety audits in ensuring workplace safety and the growing importance of safety auditors in various industries. Besides the external ISO Expert, NSC officers also addressed the summit.
- 3. A Consultative Group Meeting with senior HSE experts from the industries and the senior NSC officers was conducted by DG NSC on Wednesday, the 28th August, 2024 at NSC Office to discuss the idea about launching a new short-term course on "HSE in Oil & Gas Industries" for the frontline engineers/ new recruits of oil and gas industry in India. The Group discussed the course objectives, framework, content outlines, duration, etc. Based on the discussion, a 9-week training course on "Competency Building in Safety, Health and Environment Management for Oil & Gas Industry" was developed.
- 4. As a part of NSC's initiative to enhance membership services, a webinar on "Mental Health in the Digital Era" was organised on 22nd January, 2025 for NSC Members. The programme was aimed at providing a valuable insight on mental well-being in today's fast-paced, technology-driven work environment. A renowned expert on mental health, Dr. Monalisha Sahu, Associate Professor and Head of the Department of Occupational Health at the All India Institute of Hygiene & Public Health, under the Ministry of Health and Family Welfare, Govt. of India delivered an interactive session.

SEMINAR/CONFERENCE / CONCLAVE

1. On 26th July, 2024, NSC conducted a one-day seminar on 'Industrial Safety' at the Nashik Engineering Cluster, located in Ambad MIDC, Nashik. The event drew participation from approximately 89 industry representatives, underscoring the importance of safety awareness across sectors. The seminar was inaugurated by Smt. Anjali Ade, Joint Director of DISH, Nashik, who shared real-life case studies on incidents involving falls from heights, emergency preparedness lapses, and fire hazards in chemical industries. She also expressed appreciation to NSC for organizing such a valuable initiative in Nashik.



2. NSC organised a one-day Seminar on 'Industrial Safety' in collaboration with IPS Academy, Indore on 18th October, 2024. The seminar was aimed to bridge the gap between academic knowledge and industry requirements in safety practices, introduce participants to contemporary trends in industrial safety, enhance understanding of safety performance management and monitoring systems and strengthen the foundation for developing future safety professionals. The seminar was graced by DG, NSC as the Chief Guest along with Dr. Archana Keerti Chowdhary, Principal, IPS Academy.

3. In its pursuit to increase the reach of NSC to the interior parts of India, NSC organised a one-day Seminar on 'Industrial Safety' in collaboration with Bandel Thermal Power Station, West Bengal Power Development Corporation Ltd. at Bandel Thermal Power Township, Tribeni, Hooghly, West Bengal on 12th Dec., 2024. The seminar was aimed at introducing participants to the latest trends and innovations

in industrial safety, enhance understanding of safety performance management and monitoring and fostering the development of safety professionals dedicated to sustainable industrial growth. The seminar was inaugurated by Shri Ashis Kumar Shit, Chief Inspector of Factories, West Bengal, as a Chief Guest. DG NSC also graced the occasion and delivered a special address emphasizing the critical role of SHE Management in fostering a safer industrial environment and advancing the vision of a 'Surakshit and Viksit Bharat'.





4. NSC conducted a 1-day Seminar on Safety, Health and Environment on 27th March, 2025 at Hotel Taj Santacruz, Mumbai. The Seminar was inaugurated by Shri R.D. Dahiphale, Additional Director, DISH, Maharashtra. The Seminar had four sessions. These sessions were conducted by eminent speakers from Industry. After the Seminar, Certificates of Appreciation were presented to 250 organizations who have achieved qualifying score in NSCI Safety Awards 2024 but could not win any award from four levels of awards.

DIAMOND JUBILEE YEAR (1966-2026) OF NSC'S EXISTENCE

On 4th March, 2025, NSC entered in its 60th year of existence. On the occasion of 59th Anniversary Function of NSC held on 4th March, 2025 DG, NSC launched a Diamond Jubilee Logo specially prepared to commemorate NSC's dedicated service to the nation in the field of safety, health and environment. Various programmes are being organized during the year 2025-26.

TECHNICAL SERVICES

SAFETY AUDIT

NSC has consolidated and strengthened its leadership position in the field of OSH by conducting consultancy assignments of manufacturing, construction and service sectors. These includes Safety Audits; Review Safety Audits; Safety Audit as per State Factories Rules; Environment Safety Audit; Occupational Health & Safety Management System Audit as per IS 14489 : 2018; Preparation of Safety Report; Pre-Commissioning/Start-up/Pre-Occupation Safety Audit; HAZOP Studies; Quantitative Risk Assessment; HIRA, Preparation of Safety Manual and Preparation/Review of On-Site Emergency Plan/Emergency Evacuation Plan, NSCI Safety Rating System (NSRS); Safety Shield etc. There has been great demand for all these types of assignments.

As a major player in safety auditing, NSC has been responding to all the requests from organisations. If an assignment demands, multi-disciplinary teams are constituted under the leadership of technical officers for simultaneous fieldwork in different locations. The recommendations provided by NSC in the Safety Audit report are the source of improvement in eradicating the existing hazards and putting forth a healthy atmosphere. During the year 2024-25, in all 172 consultancy assignments were carried out.

NSCI SAFETY RATING SYSTEM (NSRS) & SAFETY SHIELD

The NSCI Safety Rating System (NSRS) is a robust, structured framework developed by the National Safety Council of India (NSCI) to evaluate the Occupational Health and Safety Management Systems (OHSMS) of organizations across various sectors. It serves as a voluntary, application-based tool designed to assess safety systems through a comprehensive lens and promote continual improvement.

NSRS evaluates safety performance through 103 sub-elements organized under 9 key areas such as safety leadership, hazard control (physical, chemical, fire & explosion), industrial hygiene, incident reporting, inspections, and emergency preparedness. The system goes beyond legal compliance, benchmarking organizations against national and international safety standards which also includes ISO 45001 and IS 14489:2018.

The assessment follows a two-stage field visit methodology:

- 1. First Visit Initial evaluation and identification of gaps.
- Second Visit Conducted within 3 months to verify implementation of recommended improvements.

Organizations are rated based on a transparent scoring system and awarded up to Five Golden Stars:***** - Excellent (>95%), *** - Very Good (85–95%), *** - Average (65–75%), * - Basic (60 - 65%)

Those scoring below 60% receive a report but no star rating. Every participant receives a detailed report highlighting strengths and improvement areas, along with a certificate of achievement.

In the financial year, 15 organisations have participated in the NSRS, out of which one organisation got 5 Golden stars.

SAFETY SHIELD – HIGHEST LEVEL OF RECOGNITION

Organizations that attain Five Golden Stars become eligible for the prestigious NSCI Safety Shield, which recognizes the highest level of safety excellence in India. The selection process involves an in-depth review of leadership involvement, safety culture, innovation, and use of emerging technologies such as digital monitoring, AI, and IoT.

The Safety Shield assessment includes:

- Assessment of safety leadership of Top management
- Field validation by NSC experts

Committee-level evaluation using defined indicators

This coveted recognition is awarded at national ceremonies and showcases the organization's leadership in safety and health practices. It not only enhances credibility but also fosters a culture of continuous improvement and zero barm.

TRAINING PROGRAMMES

Training Programmes/courses and Need-based Inplant Training Programmes

NSC offers a wide range of training programmes, including public training programmes held at various locations across the country, need-based inplant training programmes, and virtual training programmes. These programme sessions are designed to be highly engaging, featuring interactive discussions, safety videos, practical exercises, and real-world case studies.

During the year, 50 national and virtual training programmes were conducted, with approximately 1349 participants trained. Detailed information can be found in Annex-VI (Page 58). Additionally, 194 inplant training programmes were conducted on diverse topics and trained around 4960 participants in different industries. In total, 6309 individuals benefited from these training programmes.

E-learning Training Courses

NSC offers the following seven specialized e-learning courses designed to enhance the knowledge of the participants on safety, health and environmental management practices across industries. During the reporting period, in all 429 participants attended these courses.

Safety Talks / Meetings / Functions

NSC Officers delivered safety talks, presented technical papers and attended meetings/functions organized by different organizations during the year. Details are furnished in Annex - VIII (Pages 61).

National Safety Aptitude Test - 2024

The National Safety Aptitude Test (NSAT) is an online, auto-proctored examination launched by NSC in 2022. The objectives of NSAT are to assess candidates' comprehensive understanding of safety science, safety laws, risk management, safety engineering/management, leadership abilities, and general aptitude.

For the year 2024, the NSAT examination was conducted on 6th July 2024. A total of 1,064 candidates were registered for NSAT-2024, of which 992 candidates appeared for the examination, and 774 candidates successfully passed. The passing score for the examination is 50% or above.

In response to demand from organizations, NSAT was extended to the construction and oil & gas sectors starting in 2023. For the year 2024, a total of 38 candidates from the construction sector and 506 candidates from the oil & gas sector appeared for the examination, with 24 and 435 candidates passing successfully, respectively.

Safety Aptitude Test for HPCL Employees

NSC conducted a specially developed, online, auto-proctored Safety Aptitude Test (NSC-HPCL-SAT) for Hindustan Petroleum Corporation Ltd. (HPCL) engineers working in the refinery and marketing divisions. The test was held on 10th May 2024. A total of 1,534 candidates were nominated by HPCL, of which 1,472 candidates appeared for the test, and 1,439 candidates successfully passed. The passing score for the examination is 50% or above.





Assessment of Applications and finalization of the awards-2024

i. Preliminary Assessment

As part of the Stage-1 assessment, all received applications were thoroughly assessed by designated field experts in accordance with the established assessment criteria set by the NSC. These criteria cover various parameters related to occupational safety and health (OSH) performance, compliance standards, system implementation, good practices, etc. The assessment scores obtained during this stage were compiled and submitted to the NSCI Safety Awards Committee as detailed below for scrutiny. The composition of the NSCI Safety Awards Committee, constituted by the NSCI Board of Governors, is provided in Annex IX (Page 64) As per the practice top ranking organisations within the manufacturing and service sectors were visited by the experts to verify the facts that have been claimed by the applicants including OSH system implementation at site.

ii. Committee Deliberations and Presentations

The NSCI Safety Awards Committee convened three times through a virtual platform to carry out detailed evaluations and finalize the award winners.

The first meeting, held on 28th -29th November 2024, was devoted to the construction sector. During this meeting, 18 establishments that had secured top rankings in the Stage-1 assessment were invited to make detailed presentations before the Committee. These presentations focused on their occupational safety and health (OSH) systems, performance indicators, and innovative practices adopted at their worksites.

The second meeting, conducted on 23rd-24th December 2024, focused on the manufacturing and service sectors. Organizations, 17 from manufacturing and 7 service sectors, those have top-ranked based on the total scores of Stage-1 assessment and subsequent field visits were invited to present their safety management practices, implementation strategies, and overall compliance with OSH standards.

These meetings allowed the Committee to interact directly with the participating organizations, seek clarifications where

necessary, and gain deeper insights into their safety culture and performance.

iii. Finalization of Award Winners

Based on a thorough multi-stage evaluation process, which included the assessment of applications, on-site field visits and detailed presentations by top-ranked organizations, sector-wise final merit lists were meticulously prepared. These merit lists reflected the cumulative performance of each organisation across all evaluation parameters, including OHS performance, compliance with OSH standards, effectiveness of safety management systems, innovation in safety practices, and commitment to continuous improvement.

The third and final meeting of the NSCI Safety Awards Committee was held on 26th December 2024 via virtual platform. During this meeting, the compiled sector-wise merit lists were formally presented to the Committee

for review. The Committee engaged in detailed deliberations, taking into account not only the merit scores but also field visit reports, presentation outcomes, and verification inputs received from relevant authorities and clients.

After a comprehensive and objective review, the Committee finalized the list of winners for the NSCI Safety Awards–2024, recognizing organizations that demonstrated outstanding performance and sustained excellence in occupational safety and health management.

Total 64-organisations from manufacturing sector; 23-establishments from construction sector; 15-enterprises from MSME sector and 10-establishments from service sector were declared as the winners.

The results were posted on NSC website on 31st Dec., 2024 and subsequently letters sent to all award-winning organizations.

iv. Presentation of Awards

The Platinum, Golden, Silver, Bronze and Prashansa Patra level awards were presented at The Lalit Hotel, Mumbai on the 17th January 2025 after the 53rd Annual General Meeting (AGM) of the National Safety Council.

The Awards were presented at the hand of Shri Arvind R. Doshi, Vice-Chairman (Employers), NSC; Shri Girish Kumar Srivastav, Vice-Chairman (Workers), NSC; Dr. P.R. Swarup, Director General, CIDC; Shri Santosh Warrick, Director-Maharashtra Fire Service, Govt. of Maharashtra; Dr. Lalit Gabhane, Director General, NSC; Shri V.B.Ghogare, Joint Director, Director of Industrial Safety & Health, Govt. of Maharashtra and Shri A.Y.Sundkar, Director, NSC.

Total 112 organisations were received the awards in different levels – Platinum trophy with certificate, Sarva Shreshtha Suraksha Puraskar – Golden Trophy with Certificate, Shreshtha Suraksha Puraskar – Silver Trophy with Certificate, Suraksha Puraskar – Bronze Trophy with Certificate and Prashansa Patra. Along with the winners, 23 client organizations from Construction Sector have been also awarded. The winners list is provided at Annex X (Page 65).

The award function was well attended by over 400 persons from the Award-winning organisations including their family members and invitees.

SAFETY PROMOTIONAL ACTIVITIES

1. 54th NATIONAL SAFETY DAY / WEEK CAMPAIGN (4th - 10th MARCH, 2025)

The National Safety Day / Week (NSD/W) Campaign spearheaded by the Council to commemorate its Foundation Day on 4th March has celebrated 54th year of the campaign for the year 2025. The Campaign has now grown into a major national event in the OSH field and is widely celebrated by the industry, trade unions, Govt. departments, regulatory agencies, NGOs and institutions, etc. throughout the country. The theme for this year's Campaign was "Safety and Well-Being - Crucial for Vikasit Bharat".

An appeal was issued to all members and patrons via the Council's letter dated 17th December 2024 to organize the 54th NSD/Week Campaign from 4th March 2025 on a grand scale. The Campaign is aimed at renewing the commitment of employees and general public to work safely throughout the year. To assist

them in organizing the Campaign effectively, the Council, as in the past, had developed and brought out a variety of promotional literatures and utility articles carrying safety messages and slogans aimed at ensuring integration of OSH in work culture and lifestyle. During the week, all the members of NSC in their broader aspects extended their actions to families, townships, schools/colleges and community to adopt the good practices of road safety, home safety and emergency preparedness for their betterment.

Shri Deoghare, Director, NSC participated (through telephone) in the Radio Programmes i.e. Red FM 93.5, and answered their questions. Further, NSC officers were invited by NSC's Member organizations to deliver addresses at the functions organized by them on the occasion.



2. FIRE SERVICE WEEK (14th - 20th APRIL, 2024)

NSC has been actively promoting the Fire Service Week (FSW), which is held annually from 14th to 20th April under the guidance of the Fire Advisor, Ministry of Home Affairs, Govt. of India. The theme for FSW 2024, as decided by the Ministry, was "Ensure Fire Safety, Contribute Towards Nation Building".

To support members and patrons in effectively observing FSW, NSC developed and distributed a variety of promotional materials featuring key safety messages, including safety posters, photoluminescent signages, etc. These materials were supplied to various companies nationwide.



3. CELEBRATION OF THE WORLD ENVIRONMENT DAY (5th JUNE, 2024)

The World Environment Day (WED) has been spearheaded by the United Nations Environment Programme (UNEP) since 1972. NSC has been promoting the observance of the WED since 1999. The theme for WED 2024 was "Land Restoration, Desertification and Drought Resilience".

The organizations actively participated in the WED Campaign and celebrated it on their premises. For effective promotion and observance of the WED-2024 Campaign, NSC developed various promotional materials and made available to the organizations and other patrons on demand.nationwide.

NSC officials participated in WED celebration of D.Y. Patil's Dnyaypushpa Vidya Niketan School, CBD Belapur, Navi Mumbai. NSC officers addressed the students and briefed about the theme of WED-2024 and importance of the environment.




In addition to the other campaigns, NSC has been actively promoting "National Electrical Safety Week" (NESW) Campaign since 2020, with the active support of Central Electricity Authority, Govt. of India.

The objective of the NESW is to raise awareness and enthusiasm among the public and industries on Electrical Safety and to renew the commitment of the employee and public towards safe use of electricity. The theme for NESW-2024 was "Embrace Electrical Safety, Safeguard lives". NSC brought out various promotional materials with topical messages on electrical safety.



5. ROAD SAFETY MONTH CAMPAIGN (JANUARY, 2025)

The Ministry of Road Transport & Highways observes National Road Safety Month every year. Hon'ble Minister had directed to observe National Road Safety Month commencing from 1st January 2025 with the theme 'Sadak Suraksha - Jeevan Raksha'. To contribute to the cause, NSC started promoting the Road Safety Campaign from the year 2011. To assist members and patrons in effectively promoting and organizing the Campaign, the Council developed various promotional materials such as safety badges, safety banners, safety posters, films, key-chain, cap, reflective jacket, etc. with road safety messages. There was good demand for the promotional material. Members enthusiastically participated in the Campaign.



PUBLICATIONS & PROMOTIONAL MATERIAL

1. NATIONAL SAFETY CALENDAR - 2025

Since the year 1979, NSC has brought out its wall calendar depicting safety messages through attractive cartoons/pictures. The aim is to convey the safety messages to the masses every day throughout the year, in an effective and striking manner.

The arts of the Calendar for 2025 were designed by Shri Prabhakar Wairkar, a well-known cartoonist in the advertising world,

honoured with National & International Awards. The Calendar depicted important topics related to occupational safety, health, environment and hygiene through cartoons including the information sheet on "Selection, Use and Maintenance of Personal Protective Equipment (PPE) For Electrical Work". In all, 1,55,000 copies of the NSCI wall Calendar and 16000 no. of desk calendars were printed and distributed.

A copy of the Wall Calendar was provided to all NSC members as a free membership service.

2. HSE DIARY-2025

Health, Safety & Environment (HSE) Diary has been published by the Council since 1998 with an objective to disseminate the useful information on HSE for day-to-day usage and reference. The information provided in the Diary-2025 was on diverse topics. The Diary-2025 had 244 pages of which about 68 pages containing information on HSE.

The orders received for 34,734 copies from organizations including industries, institutions, regulatory agencies, professionals, etc. were executed. Total 36,000 copies (including complimentary) were printed and distributed to the members and patrons.



3. SAFETY POSTERS

NSC maintains a stock of Safety Posters in English and Hindi languages. Every year new posters on the relevant topics are printed and added to the stock.

During the year, 36,000 copies of posters were printed. Total 46075 posters sold. NSC supplied 12 types of safety posters as part of the membership service to all its Corporate Members free of cost. Further, during the year, 74 copies of Pen Drive, 141 books and 5277 signages were sold on the topics of Safety, Health and Environment.

4. INDUSTRIAL SAFETY CHRONICLE

The quarterly journal 'Industrial Safety Chronicle' is regularly published and four issues were released during the year. The copies were sent to all members as part of the complimentary membership service. Additionally, copies were sent to subscribers, NSC Board Members, Union Ministries of Labour & Employment, Environment, Forest & Climate Change; DGFASLI, Regional Labour Institutes, Chief Inspectorates of Factories, Pollution Control Boards; and other relevant government agencies related to Occupational Safety and Health (OSH), as well as other stakeholders on a reciprocal or complimentary basis. Also, these issues were provided on the membership portal "NSC-Connect" for accessing to NSC members.

The four issues were focused on a theme:

- April–June 2024: Success Stories of NSCI Safety Award Winners 2024
- July–September 2024: Safety in Warehouses & Logistics Industry
- October-December 2024: Road Safety
- January–March 2025: Mental Health & Wellness at the Workplace

This thematic approach ensured that each edition provided valuable insights on critical safety topics across different industries and sectors.

5. INDUSTRIAL SAFETY NEWS

A total of six issues of the bi-monthly "Industrial Safety News" were published throughout the year in the form of an e-newsletter. Soft copies of each issue were emailed to all members as part of the complimentary membership service. In addition, the newsletters were made available for free download on the NSC website as well as membership portal "NSC-Connect" for accessing to the NSC members. The newsletter served as a key resource for keeping members informed about the organization's activities, newly developed NSC services, and special assignments undertaken by the NSC. It also provided valuable updates on safety-related matters, including changes in regulations and amendments to legislation concerning safety, health and environment.

6. LIBRARY

The NSC maintains a well-equipped library that is accessible to its members, students, and employees. The library's collection comprises approximately 3,300 technical books, manuals, reports, handbooks, codes, standards, conference proceedings, and other resources focused on safety, health, environmental issues, and related subjects. To keep the collection up to date, new titles are regularly added each year.

NSC also receives periodicals from reputed international and national organisations, which also displayed in the library.

On the occasion of World Day for Occupational Health and Safety, the National Safety Council - Kerala Chapter, in collaboration with Cochin Shipyard and BPCL Kochi Refinery, conducted the Safety Marathon – Run for Safety 4.0. This event aimed to raise awareness about the implications of climate change for workplace safety. The marathon took place on Sunday, April 28, 2024, at 6 am, starting from Ernakulam International Stadium.

The marathon sought to highlight the impact of climate change on industrial workers. Approximately 500 participants, including workers from various industries and students, joined the event to support this cause.

b. A National Seminar on "Al and Emerging Technologies for Enhancing Occupational Safety in Industries" was held on March 28–29, 2025, at the AGORA Auditorium, IIT Palakkad, Kerala. Organized by The Institution of Engineers (India) – Palghat Local Centre, in association with the Department of Factories & Boilers, Government of Kerala, and the National Safety Council – Kerala Chapter, The seminar focused on the role of Al and emerging

technologies in improving industrial safety. The event saw participation from around 300 delegates representing various industries and academic institutions.

c. National Safety Week Celebrations-2025: As part of the National Safety Week Celebrations 2025, the National Safety Council - Kerala Chapter organized several events in collaboration with Toc H Institute of Science and Technology. A "Run for Safety" marathon was held on March 4, 2025, with over 150 students and faculty participating in a 5 km run from Hill Palace Museum to NSC Kerala Chapter, flagged off by Shri Rajeev C. On the same day, a Safety Flag Hoisting Ceremony was held at NSC-KC, Irumpanam, led by Honorary Secretary Shri A. L. Jackson, followed by the administration of the safety pledge. MINUTES OF THE 53rd ANNUAL GENERAL MEETING OF NATIONAL SAFETY COUNCIL

(HELD AT 1245 HRS. ON FRIDAY, THE 17th JANUARY, 2025 AT THE LALIT HOTEL, MUMBAI)

- 1. The 53rd Annual General Meeting (AGM) of the National Safety Council was held at 1245 hrs. on Friday, the 17th January, 2025 at The Lalit Hotel, Near Chhatrapati Shivaji Maharaj International Airport (Terminal 2), Sahar Airport Road, Andheri (East), Mumbai as notified through the Notice-cum-Agenda letter No. NSC/ADMN/517/AGM-53/2024 dated 6th Dec., 2024.
- 2. Dr. Gabhane welcomed all the Members. He informed the members that the term of Shri S.N. Subrahmanyan as Chairman of NSC has ended on 3rd February, 2024 and the matter of nomination of new chairman is being pursued with the Ministry of Labour and Employment, Govt. of India and NSC may have a new Chairman shortly. Dr. Gabhane also informed the members that the Board of Governors of NSC at its 188th meeting held on 26th April, 2024, as per provisions under Rule 9(b) (iii) of Rules & Regulations of the Council has decided that the Vice Chairman (E), NSC, Shri Arvind Doshi would act as Chairman till the nomination of new Chairman by the Ministry. In view of this, the meeting was chaired by Shri Doshi. Along with Shri Doshi, Shri G.K. Srivastav, Vice Chairman (Workers) and Shri Lalit R. Gabhane, DG, NSC were on the dais. To encourage people to renew their commitment to the safety of mankind and spread safety


awareness among the public, Dr. Lalit R. Gabhane, DG, NSC administered the Safety Pledge to all the members present at the AGM.

- First of all, I thank the Board of Governors of NSC and all the members of the Council for deposing the faith and trust in my capabilities in taking the Council further ahead.
- 2. With great pleasure, I would like to extend a very warm welcome to you all at this 53rd Annual General Meeting of the National Safety Council for the F. Y. 2023-24.
- 3. I wish to inform you that Shri S.N. Subrahmanyan (CMD of L&T) has completed his term as Chairman NSC on 3rd February, 2024. Today, our NSCI Safety Awards-2024 Function for felicitating the winners will be held after this AGM. I request all of you to attend the Awards Function, as well.
- 9. The safety community eagerly awaits NSC's Safety and Health Conferences. It is my delight to announce that NSC India will be hosting the 39th Asia Pacific Occupational Safety and Health Organisation (APOSHO) International Conference along with Expo on 27th & 28th November, 2025 at Yashobhoomi known as India International Convention Centre, Dwaraka, New Delhi. The details about the venue, dates, theme, etc. are already posted on our website. I urge all members to promote and participate in this International Conference in a large number, as it is being held almost after 9 years.

Statement of Accounts for the Financial Year ending on 31st March 2024 was posted on NSC Website in the second week of December 2024. Allow me to present a concise overview of the Council's achievements during the financial year 2023-24.

The NSC sustained its growth momentum in the Financial Year 2023-24, achieving more than 13% increase in income from various activities compared to the previous year. This increase shows the growing popularity of NSC services and the trust industries placed in the Council. Details of the Audited Income & Expenditure Statement and the Balance Sheet for F.Y. 2023-24 are provided in the Annual Report.

NSC has broad-based membership categories like corporate, trade-union, life & individual and student and every year new members are being enrolled to expand its network across

India. I am happy to inform you that, during the year, NSC has achieved 5-digit figure of NSC memberships. The overall membership as of 31st March 2024 was 10,045 as against 9,781 of 31st March 2023.

To enhance NSC's outreach and to provide services across the country, NSC has set up state chapters. In the Financial Year 2023-24, NSC had a network of 12 Chapters in different States to cater to the needs of its members at local level and in local languages. As per NSC Board's directive, these Chapters are registered under the Societies Registration Act in their respective states.

As per the objectives stated in the Memorandum of Association, NSC has set goals by deeply analyzing its services and activities and trying to improve & enhance them. To meet the goals, NSC networks with various organizations. I am



4. ADDRESS BY THE VICE CHAIRMAN (E), NSC

Dear members, over the past 58 years, the NSC has played a pivotal role in supporting its member organizations by providing diverse services in the domain of occupational health, safety, and the environment. The year 2023-24 witnessed the NSC's outstanding performance, demonstrating its commitment to service excellence and collaboration with industries for safety and health.

The Annual Report, along with the Audited



happy to share highlights of a few activities and services undertaken during the FY 2023-24.

- NSC has been consistent in its approach to have long term collaborations with leading national & international organisations and entering into agreement with them & supporting to fulfil mutual OHS needs. As a part of these efforts, during the year NSC has signed and renewed MoUs with:
 - i. Construction Industry Development Council (CIDC), New Delhi
 - ii. Petroleum and Safety Organization (PESO)
 - iii. Land Port Authority of India, Statutory Body under Ministry of Home Affairs, Govt of India
 - iv. SAIL Safety Organization
 - v. Indian Association of Amusement Parks & Industries, Mumbai
- A 1-day National Conclave on Safety, Health & Environment (SHE) was organised by the Council on 15th March 2024 at Hyderabad, Telangana. The theme of the Conclave was "ESG Excellence through Safety Leadership". The Conclave was a grand success, which was attended by over 470 participants including invitees, session's chairmen, speakers, delegates and exhibitors. A total of 17 speakers including international contributed to the deliberations of the Conclave in the four technical sessions. After the Conclave NSCI Safety Awards-2023 presentation ceremony was held.

- As a part of NSC's object in creating awareness on safety, NSC conducted a two 1-day complimentary Seminars on "Safety in Agriculture Sector" and "Health and Safety of Contractor Workers at Kota, Rajasthan and Durgapur, West Bengal on 10th February, 2024 and 20th March, 2024, respectively. These seminars were very well appreciated by the participants.
- I am happy to inform you that the NSC's new initiatives namely Safety Rating System, NSCI Safety Shield and NSAT are receiving very good response from the industries.
- NSC has been pioneering in consultancy services and has established its strong footprints in the field of OSH by undertaking Consultancy Assignments comprising of various types of Safety Audits, Safety Rating, HAZOP Studies, HIRA, Mock Drill, etc. There has been a great demand for all these types of assignments. During the year 2023-24, in all 185 consultancy assignments were carried out.
- NSC provides training on a wide range of OSH topics catering to the needs of NSC members. During the year, 42 national and virtual training programmes were conducted from which 1,054 participants benefited.
- NSC also conducts need-based training programmes at the premises of organizations. During 2023-24, a total of 138 such programmes
- were conducted on various topics and trained 3,475 participants. NSC also has e-learning training courses on different subjects available throughout the year.

- NSC is spearheading the major national campaigns in the field of safety, health and environment in the country for promoting safety and creating safety awareness among masses. These campaigns include National Safety Day, Road Safety Month, Fire Service Week, World Environment Day and National Electrical Safety Week. To celebrate/observe these campaigns NSC produced a variety of promotional materials, and the response received from members was overwhelming.
- All of you are aware that NSC is operating four distinct NSCI Safety Award Schemes annually for manufacturing, construction, MSME and service sectors. The NSCI Awards are very popular in industry as the responses received for NSCI Safety Awards-2023 were very good compared to last year. A total number of 676 applications were received, which is higher by 12% as compared to the previous year.
- The winners of the NSCI Safety Awards-2023 were felicitated during NSC's Conclave on Safety, Health and Environment held at Hyderabad on 15th March, 2024.

BIS is the National Standards Body of India engaged in developing Indian Standards in various fields of industrial activities, products, testing methodologies and services. The standards are being developed by various technical committees constituted by BIS. NSC being an apex national institution in the area

of occupational health & safety, DG-NSC chairs two sectional committees of BIS namely Chemical Hazards and Occupational Safety & Health. NSC officers are also members on various committees and contributes to developing the Indian Standards.

NSC is constantly striving hard to develop and introduce newer activities in its mission of promoting Safety, Health & Environment at the national level. It is gearing up for future challenges with initiatives such as launching of safety innovation awards for students and young entrepreneurs; safety education platform for students; conducting awareness programmes at different locations across the country and digitalization of NSC activities/services.

As informed by DG in his welcome address, NSC is hosting APSOHO-39 in India in November 2025. As done in the earlier APOSHO Conferences, I appeal all NSC members to extend their full support to APOSHO-39 to

exhibit the international guests that India is doing the best efforts in creating safety awareness and making our workplaces safer.

In conclusion, I extend my gratitude to all members and patrons for their ongoing co-operation and support in advancing NSC's mission of providing quality and affordable services in Occupational Safety and Health across the nation.
