



NSCI E-learning Course on “Industrial Safety”

Objective of the Course:

Safety is everyone’s responsibility, and building a safer and healthier work environment should be management’s top priority. Adopting proper safety procedures begins with individuals, and will help in the development of preventive culture. This course will educate an individual employee about identification, measurement, prevention and control of workplace-related hazards.

Participant will be given 3 attempts to pass the module. Unless the participant clears the module, he/she cannot proceed further to the next module. If the participant is unable to pass any module in 3 attempts, the course will get terminated automatically. • Certificate: Certificates can be downloaded after the successful completion certificate from the elearning site.
