# “Safety of Gas Cylinders”

**PERSPECTIVE:** Compressed gas cylinders are used for the various activities of industries and domestic purposes. These gas cylinders possess hazards and can cause fires, explosions, oxygen deficient atmospheres, toxic gas exposures as well as the innate physical hazard associated with cylinders under high pressure. Special precautions in respect of the storage, use, and handling of gas cylinders are necessary to ensure the safety of workers, equipment and property. Because of limited knowledge of compressed gas cylinder safety, accidents can happen. Hence, to avoid accidents, awareness of gas cylinder safety is very essential. This program will provide the guidance to the participants on the significance of Safe storage, handling and use of gas cylinders in factories and plants.

**OBJECTIVE:** On completion of this program, the participant will be able to understand the legal requirements, safety aspects and good practices for safe use, handling and transportation of gas cylinders.
