## "Promoting Safe Practices in Material Handling"

11 April, 2025 (Time: 01:00 PM to 05:00 PM)

**PERSPECTIVE:** Handling and storing materials involve diverse operations such as hoisting tons of steel with a crane; driving a truck loaded with concrete blocks; carrying bags or materials manually; and stacking palletized bricks or other materials such as drums, barrels, kegs, and lumber. The efficient handling and storing of materials are vital to industry. Unfortunately, the improper handling and storing of materials often result in costly injuries. In addition to training and education, applying general safety principles such as proper work practices, equipment, and controls can help reduce workplace accidents involving the moving, handling, and storing of materials. Whether moving materials manually or mechanically, employees should know and understand the potential hazards associated with the task at hand and how to control their workplaces to minimize the danger. This program will provide the guidance to the participants on the significance of Safety in Material Handling.

**OBJECTIVE:** On completion of this program, the participant will be able to understand importance of Safety in Material Handling and methods for eliminating or at least minimizing the hazards.

**TOPIC:** This 4 - hours video based virtual class room training program will cover following topics:

- Statues for Material Handling
- Manual Material Handling
- Mechanical Material Handling
- Safe Slinging Practices

TRAINING METHODOLOGY: This program will be conducted in 4 hours video based session.
