INTRODUCTION

Over the years, various industrial sectors and other establishments in our country have shown marked improvements in their Occupational Safety, Health and Environment performance and enhanced awareness. However, the performance needs to be measured on a defined scale and against the relevant parameters. At present, there is no platform in Indian context to scale and motivate the organizations for continual improvements. The mere practice of compliance to the statutory requirement as a bench mark of safety standard and adhering to the prescription of consultants are no longer attractive to organisations. With the substantial economic growth in India, the workers also demand a safe workplace and in this process Indian companies are now looked upon to be comparable with those in the developed countries.

NSCI Safety Rating System for Factories, Construction Sites, Hospitals, Hotels, Malls, ports, airports, mines, rail, metro rail, hospitals, hotels, IT parks and commercial establishments. other Commercial establishments is formulated - to evaluate the Occupational Health, Safety (OHS) and Environmental status and compare the Establishments with the same yardstick.

NSCI Safety Rating is an in-depth assessment on 8 key elements, comprising of around 84 sub-elements aimed at achieving excellence in the OSH management system. It uses questionnaire with detailed guidance for evaluation. Reference to the relevant national statutes and standards is the unique feature of the process. NSCI Safety rating system is modeled on IS 14489-2018 Code of Practice on Occupational Health and Safety Audit, National and International best practices and is at par with international standards. In its pursuit to strengthen the voluntary national movement on SHE and to better serve the nation, NSC has developed this best suited indigenous system of Safety Rating.

OBJECTIVE

NSCI Safety Rating System (NSRS) is a comprehensive tool developed to carry out qualitative and quantitative objective assessment of organization's Occupational Safety, Health and Environment management system as per the industry specific standards and national / international best practices and motivate the organizations for continual improvements to achieve zero harm goals.

NSRS is suitable for all types of factories and plants, construction sites, ports, airports, mines, rail, metro rail, hospitals, hotels, malls, IT parks and commercial establishments.

NSCI SAFETY RATING – VALIDITY AND RECERTIFICATION >>

Validity of NSCI Safety Rating :

- **3 years** – Factories, Hospitals, Hotels, Malls and ports, airports, mines, rail, metro rail, IT parks and commercial establishments.
- **2 years** - Construction site.

Apply for Recertification :

Three months prior to the expiry of validity period.

On request, additional safety advisory visit may be conducted between Two visits of NSRS to provide guidance and help organization to comply points raised in 1st visit of NSRS.
