NSCI Hosts APOSFO 39 - Conference, Committee Meetings & AGM

National Safety Council of India (NSCI) hosted the APOSFO-39 Conference on Safety, Health & Environment (SHE) from 26th to 29th November 2025 at the India International Convention and Expo Centre, Yashobhoomi, Dwarka, New Delhi. The theme of the two-day International Conference, held on 27–28 November 2025, was **"Safer & Healthier World through Innovations and Collaborations."** Meetings of the APOSFO Committees and the Annual General Meeting were held on 26 and 29 November 2025, respectively.

The vibrancy of the Conference was reflected in the following numbers:

- A total of 715 participants attended the two-day conference, including 503 national and 44 international delegates, invitees, sponsors and exhibitors.
- In all, 77 resource persons (57 national and 20 international) participated in the deliberations—comprising 3 keynote speakers, 5 CEOs, 3 moderators, 13 panellists, 13 session chairpersons, and 40 speakers.



L&T-SuFin – Shubhaarambh: First Ever Customer Meet Focused on Safety & EHS Culture



LEGAL UPDATES:

(November – December 2025)



The Gas Cylinders (Fourth Amendment) Rules, 2025

The Ministry of Commerce and Industry (MoC&I) on November 13, 2025, notified the Gas Cylinders (Fourth Amendment) Rules, 2025, further, to amend the Gas Cylinders Rules, 2016. The following has been stated:-

- In rule 2, for clause (xxviii), the following clause has been substituted, and the clause defines a "gas cylinder" as a closed metal container of >500 ml and ≤1000 L for storing or transporting compressed gases, including LPG, LNG, CNG, hydrogen, composite and cryogenic containers, excluding those on special transports. It allows larger cylinders up to 3000 L for hydrogen, CNG, nitrogen and compressed air, with specified maximum diameter limits (60 cm for nitrogen/air and 80 cm for hydrogen/CNG).

The amendment has been come into force 13 November 2025 - vide Notification No G.S.R. 839(E).


