



## NSCI'S SPECIAL NEED BASED TRAINING WEBINARS (SNW) ON Various Topics of Safety, Health & Environment

### PERSPECTIVE:

Safety, Health and Environment is a multidisciplinary subject. Regular SHE training programs often do not cover some area which are important for risk mitigation. There are some special areas like QRA, HIRA, Laboratory Safety, HAC, Fire protection, Safety during pre-commissioning, work in confined space, Disaster management, Warehouse safety etc which need to have a special focus so as to prevent serious and fatal accidents.
