NSCI'S VIRTUAL CLASSROOM TRAINING PROGRAM ON "Permit to Work Issuer's course" 16 March, 2023 (Time : 14 : 00 HRS)

PERSPECTIVE: A permit to work system is a formal written procedure which is designed to give greater control over tasks that involve more severe risks. It sets out the measures required to complete the work safely, based on a risk assessment. This is, in particular, required when the work has foreseeable high risk activities. This course will enable you understand the essential components of the Permit to Work system, the mechanics of implementing the system and how to monitor its effectiveness in your role as a Permit Issuer. Practical application of permits, including worksite inspection, isolation requirements and permit auditing procedures, will reinforce learning and ensure you are confident to issue and close permits in the workplace.

OBJECTIVE: Gain a comprehensive understanding of Permit Issuer procedures to enable you have the controls in place to safely and effectively complete the task. This course will also teach participants the limitations of each permit, and in making decisions regarding the need for and correct use of each permit.

TOPIC: This virtual class room training program will cover following topics:

- Roles and requirements for issuing a permit
- Selecting the most appropriate permit for the work task
- Life Cycle of a Permit To Work
- Legal responsibilities
- Permit to Work (PTW) key players
- PTW documentation
- Practical application of PTW



TRAINING METHODOLOGY: This program will be conducted in 3 hours video based session.

WHO SHALL ATTEND : Project Managers, Site Engineers, Safety Officers, Supervisors, Trade Union, Newly joined employees, personnel involved in work permit issuing process etc.
