PERSPECTIVE: Management practices like Engineering Revision, Instructions, Personal Adjustment and Discipline, etc. have resulted in improving Safety Standards and reducing unsafe situations and accidents. Keeping in view of the need, in the recent past safety professionals have developed a new approach known as “Behaviour Based-Safety”. This approach is based on successive years of research which showed that about 80% of accidents at the workplace are caused by unsafe behaviours. In this approach Behaviour is considered as a base for improving safety performance because it is observable, definable & measurable also. Behaviour based safety is not a stand-alone solution to creating safety culture change in your company, there is still great value in the safety hierarchy and a safety management systems, but instilling behaviour based safety practices is a vital part of building a successful and lasting safety culture. This program will provide the guidance to the participants on the significance of Behaviour Based Safety and how it helps in creating safety culture.

OBJECTIVE: On completion of this program, the participant will be able to understand the concept and principles of BBSM to improve their safety performance and develop safety culture.
