Sub: 21st Election to the Board of Governors of the National Safety Council

Dear Sir,

I am pleased to inform you that as per Rule 7(d) of the Rules and Regulations of the Council, the 21st Election to the Board is scheduled for all 32 seats across 26 Constituencies. Pursuant to this rule, circulars were dispatched from NSC HQs on 13th February 2024 by post. In case any member has not received the election circular, it can be downloaded via the link provided below.

The circular contains the names of the Board Members who will continue until the results of this Election are declared (Annexure–I), along with the enclosed Election Rules (Annexure–II).

Nominations are invited using the prescribed nomination form. These forms should be submitted as hard copies to the Director General, National Safety Council, in sealed envelopes marked as **"NOMINATION FORM – 21ST ELECTION TO NSC BOARD OF GOVERNORS."** Each nomination must be proposed by an eligible Member and seconded by another eligible member from the same constituency. Contesting members, proposers, and seconders are required to attach valid membership certificates. Membership certificates can be downloaded from the NSC Connect Portal: <https://connect.nsc.org.in>.

The hard copy of the duly filled-in nomination form along with the original signature and Seal (if Applicable) must be sent to the NSC HQ office on or before the last date.

No nomination form will be accepted by email.

It is imperative to mention that a members in arrears of the Membership Subscription is not eligible to contest, vote, or propose/second another member. However, if the member clears the payment of arrears before 11th April 2024 (the closing date for submitting Nominations), they will be eligible for this Election.

Important Dates:

As per Rules 11 & 14 of the Election Rules, the schedule for submission and withdrawal of Nominations is as follows:

Last date for the Receipt of duly filled in Nominations in NSC Office	11th April, 2024 (till 6.00 p.m.)
Last date for withdrawal of Nominations	29th April, 2024 (till 6.00 p.m.)

No Nomination will be accepted or allowed to be withdrawn after the respective dates mentioned above.

As the Board of Governors is the highest policy-making body of NSC, nominations of **Senior Management Persons**, such as **Managing Director, Director, Executive Director, Executive Vice President etc. should be proposed** as they can effectively contribute to the deliberations of the Board.

In case of a contest, Ballot Papers will be printed and sent to all Members.
